A. Founding Members - \$1,000.00

This category is open to current member organizations and entities. Each founding member is offered an at-Large Board seat.

B. Statewide Associations - \$500.00

This category is open to all Statewide Associations who have an interest in the success of the travel and tourism industry of the State. Each member association has a seat on the Board of Directors representing their specific industry segment. All members of the Association are eligible for membership in NJTIA for the member association rate.

C. Regional Associations and Business Organizations - \$300.00

This category is open to all regional or countywide associations or business organizations such as chambers of commerce, county public affairs departments, etc. All members of the regional associations or organizations are eligible for membership in NJTIA at the member association rate.

D. Local Associations and Business Organizations - \$200.00

Same as the regional category applied to local organizations.

E. Governmental Entities - \$200.00

This category is open to any governmental entity or operation that has an interest or role in the promotion and success of the travel and tourism industry of the State.

F. General Membership - \$200.00

This category is open to all organizations and entities and individuals that do not fit any of the above categories.

G. Member of Member Associations/Organizations - \$35.00

This category is open to any member of a member association/organization or founding member's entity.

DMO - \$750

This category is open to any Destination Market Organization. This level of membership includes a board seat.
